To help us maximize commercial values of any equipment, if your device such as an Apple iPhone, laptop or Chrome type device, please reset your account details prior to bringing the device to us.

All equipment as received at our collection facility will be processed as follows:-

- 1: Stored and transported under clearly defined security procedures, including storage, transportation, processing, recycling and resale.
- 2: If the equipment has a commercial resale value...

Or

- 2.1: The device will be data erased to certified standards.
- 2.2: If the device has a data storage capacity that can not be data erased the data element will be physically destroyed.

Or

- 3: If the equipment has zero commercial resale value...

- 3.1: The equipment will be disassembled for reusable component parts or physically destroyed and recycled in compliance with the WEEE regulations. Any data storage capacity will be physically destroyed.

Our data erasure and physical destruction processes guarantee no data will be passed to a 3rd party.

All equipment will be separated into items that can be;

- A: Refurbished for resale
- B: Disassembled for component parts sale
- C: Destroyed for recycling

By signing this document you as the equipment owner agree to pass ownership for the device as listed above to us for processing in compliance with this agreement. You accept that we will take all reasonable care with deleting your data from the device prior to any of the above processes. We will not view, copy or disclose any data held within the device. Our guideline timescales to process your equipment are within 7 days of receipt at our facility. A report of data erasure or destruction will be emailed to the email address provided by you no later than 10 days after receipt at our facility. Whilst the equipment remains in our possession it will be stored, transported in as secure manner as possible. All processing will be carried out here in Jersey using professionally trained ITHS staff.
